INFORMATION MEMO

for foreign citizens wishing to enter the Russian Federation for the purpose of medical treatment

Attention!

- 1) The arrival of a foreign citizen in the Russian Federation for the purpose of treatment under the restrictions adopted by the Russian Federation, taking into account the current epidemiological situation, it is advisable to consider as an urgent need for the provision of highly qualified assistance by the medical personnel of medical institutions of the Russian Federation.
- 2) The provision of false information by a foreign citizen to obtain a permit to enter the territory of the Russian Federation for the purpose of treatment, as well as the provision of forged documents confirming an invitation to treatment in medical organizations of the Russian Federation when crossing the state border of the Russian Federation, is criminalized in accordance with Article 322 of the Criminal Code of the Russian Federation "Illegal crossing of the State Border of the Russian Federation".

This information note is valid under the conditions of restrictions related to the current epidemiological situation for the new coronavirus infection (COVID-19).

Recommendations:

1. A foreign citizen must choose a medical organization to receive medical services. Please note that the form of ownership of a medical organization does not matter. A foreign citizen has the right to apply to both public and private medical organizations.

- 2. After selecting a medical organization, you must contact its representatives. A medical organization may request information from a foreign patient that is necessary to clarify the possibility of providing medical services requested by a foreign citizen, as well as to make a decision on issuing documents for an invitation.
- 3. Currently, the following procedure for processing documents for entry into the territory of the Russian Federation is in effect:
- a) for citizens of foreign countries subject to a visa-free regime, in conditions complicated by the current epidemiological situation related to the new coronavirus infection (COVID-19), in accordance with the decree of the Government of the Russian Federation No. 635-r of March 16, 2020, a foreign citizen has the right to enter the Russian Federation for treatment.

From March 23, 2021, the twelfth paragraph of paragraph 2 of the order of the Government of the Russian Federation of March 16, 2020 No. 635-r in accordance with the order of the Government of the Russian Federation of March 23, 2021 No. 737-r is set out in the following wording:

"persons entering the Russian Federation for the purpose of treatment, subject to the presentation of valid documents proving their identity and recognized by the Russian Federation in this capacity, and a visa or visa-free procedure in cases provided for by international treaties of the Russian Federation, information about which is sent by a medical organization in accordance with the algorithm for submitting applications for entry into the Russian Federation of foreign citizens, including for the purpose of receiving medical services, approved by the operational headquarters for the prevention of the import and spread of new coronavirus infection on the territory of the Russian Federation, using the federal state information system "Unified Portal of State and Municipal services (functions)" in the departmental segment of the Ministry of Finance of the Russian Federation of the state system of migration and registration records, as well as the production, registration and control of the circulation of identity documents, for subsequent referral to the departmental segment of the FSB of Russia of the specified state system;".

Thus, starting from March 23, 2021, medical organizations must enter information about foreign citizens entering for the purpose of treatment using the federal state information system "Unified Portal of State and Municipal Services (Functions)".

b) In respect of citizens of foreign states who are not covered by the visa-free entry procedure to the Russian Federation, in the case of a positive decision of a medical organization regarding the possibility of providing medical services to a foreign citizen.

a citizen in this medical organization, such a medical organization should apply to the migration

department of the territorial body of the Ministry of Internal Affairs of Russia at the regional level with a request for an invitation to enter the Russian Federation for a foreign citizen or a stateless person for the subsequent registration of an ordinary business visa for the purpose of "treatment".

In addition, we note that the list of documents provided together with the application, the procedure and terms for issuing an invitation are determined by paragraphs 24, 27, 62-82 and 122-131 of the Administrative Regulations of the Ministry of Internal Affairs of the Russian Federation on the provision of State Services for the registration and issuance of invitations to enter the Russian Federation for Foreign Citizens and Stateless Persons, approved by Order of the Ministry of Internal Affairs of the Russian Federation No. 735 of September 21, 2017 (this information is available on the official website of the Ministry of Internal Affairs of the Russian Federation in the subsection "Legal information" of the section "For citizens»);

- at the choice of the applicant, the invitation can be issued on paper or in the form of an electronic document;
- the issued invitation is sent to a foreign citizen to apply to a diplomatic mission or consular office abroad, where the issue of a visa is considered on the basis of this invitation;
- accompanying the patient should apply for a "private" visa for the purpose of a "guest" trip. Thus, when crossing the border of the Russian Federation, along with an identity document and a visa, you must present documents issued by a medical organization confirming an invitation to treatment, indicating the time of treatment (copies of documents).

Please note that information about foreign citizens who are not covered by the visa-free regime must also be entered using the federal state information system "Unified Portal of State and Municipal Services (Functions)" to ensure the possibility of crossing the border of the Russian Federation.
